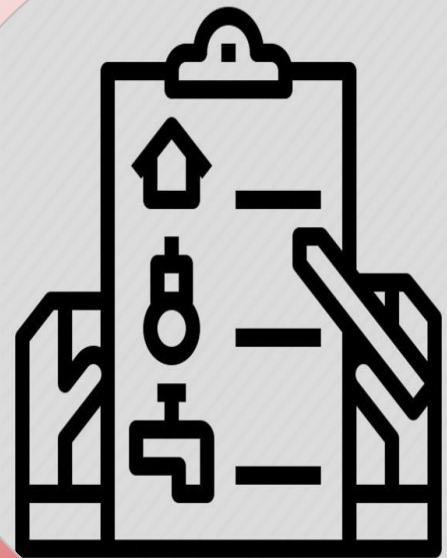

Domain 47.2 CLINICAL GOVERNANCE AND CLINICAL CARE

Sub Domain 47.2.1 7 Clinical management

Standard 47.2.1.1 7(2) (b) A health establishment must establish and maintain systems, structures and programmes to manage clinical risk.

Criterion 47.2.1.1.1 7 Infection prevention and control measures must be implemented in the feed preparation area.

47.2.1.1.1.1 A feed preparation area is available.

Assessment type: Observation - **Risk rating:** Vital measure

Verify whether there is a dedicated area available for preparing and storing feeds for new-born babies and infants who are not feeding directly from their mother's breast.

47.2.1.1.1.2 Access to feed preparation area is restricted.

Assessment type: Observation - **Risk rating:** Essential measure

The feed preparation area must restrict access to encourage infection prevention and control practices.

Verify whether there is a sign on the door that limits entry.

47.2.1.1.1.3 Disinfectant solutions for use in feed preparation unit are available.

Assessment type: Observation - **Risk rating:** Essential measure

Verify whether disinfectant solutions are available and not expired (where applicable).

47.2.1.1.1.4 Material and equipment to clean/disinfect utensils in the feed preparation area are available.

Assessment type: Observation - **Risk rating:** Essential measure

Verify whether material and equipment to clean and disinfect utensils in the feed preparation area are available and functional.

47.2.1.1.1.5 Information on frequency for replacement of disinfectant solutions is displayed.

Assessment type: Observation - **Risk rating:** Essential measure

Verify whether the frequency for replacement of disinfectant solutions is displayed in the feed preparation area.

47.2.1.1.1.6 The baby formula is kept in a lockable storage cupboard or room.

Assessment type: Observation - **Risk rating:** Essential measure

Verify whether the storage cupboard or room where baby formula is lockable and kept locked.

Sub Domain 47.2.2 8 Infection prevention and control programmes

Standard 47.2.2.1 8(1) The health establishment must maintain an environment, which minimises the risk of disease outbreaks, the transmission of infection to users, health care personnel and visitors.

Criterion 47.2.2.1.1 8(2)(a) The health establishment must ensure that there are hand washing facilities in every service area.

47.2.2.1.1.1 Hand washing facilities are available in the feed preparation area.

Assessment type: Observation - **Risk rating:** Vital measure

Use the checklist below to check whether the items listed below are available. Score 1 if the aspect is available and 0 if it is not available.

47.2.2.1.1.2 Alcohol based hand rub is available.

Assessment type: Observation - **Risk rating:** Vital measure

Select three areas and observe whether alcohol-based hand rub is available. Score 1 if available and 0 if not available. Smaller unit might not have three areas for assessment.

47.2.2.1.1.3 Posters on hand hygiene are displayed.

Assessment type: Observation - **Risk rating:** Essential measure

Select three areas and observe whether posters on hand hygiene are displayed. This could be a single hand hygiene poster or individual posters for hand washing or correct use of alcohol-based hand rub. Score 1 if available and 0 if not available. Smaller unit might not have three areas for assessment.

Criterion 47.2.2.1.2 8(2)(d) The health establishment must ensure that health care personnel are protected from acquiring infections through the use of personal protective equipment and prophylactic immunisations.

47.2.2.1.2.1 Personal protective equipment is worn.

Assessment type: Observation - **Risk rating:** Vital measure

Verify whether the protective clothing and equipment listed below is worn. Score 1 if the item is available and worn and score 0 if not available or not worn. Score not applicable where, at the time of the inspection, milk kitchen personnel are not in a situation requiring them to wear protective clothing.

Sub Domain 47.2.3 9 Waste management

Standard 47.2.3.1 9(1) The health establishment must ensure that waste is handled, stored, and disposed of safely in accordance with the law.

Criterion 47.2.3.1.1 9(2)(a) The health establishment must have appropriate waste containers at the point of waste generation.

47.2.3.1.1.1 Appropriate containers for disposal of waste are available.

Assessment type: Observation - **Risk rating:** Vital measure

Verify whether the general waste containers are available in the unit. This could be a wall mounted or a disposable or reusable vessel placed at the point of waste generation for the purpose of receiving waste. It may include but not limited to a bin, bucket, box, etc. The container must be lined with the appropriate colour coded liner (black, beige, white or transparent). Not applicable: Never
